Safety first this spring

Whether planting or trimming trees, using ladders outside, planting crops or flying kites or drones, thinking about electric power line safety is very important this spring.

Trimming trees or bushes near power lines can be dangerous because electricity can arc from the power line to the tool, potentially causing injuries or even death. When working near power lines, look up and stay at least 10 feet away at all times.

Before you dig, call us

If you are planting trees or bushes this spring, South Kentucky RECC says not to dig into more than you bargained. There could be electric lines buried at your proposed digging site with anywhere from 120 volts of electricity up to 14,400 volts in them.

Two days, or more, before doing any type of digging, excavating or blasting within the South Kentucky RECC service area, please notify the co-op's underground notification center. Call your local SKRECC office or (800) 264-5112 and ask for the dispatcher.

Dispatchers are on duty 24 hours a day, seven days a week. The dispatcher will ask for your name, phone number, the type of digging or other work that will be done, when you plan to begin work, the name of the person responsible for the work, directions to the digging site and the



nearest South Kentucky RECC service or meter number. SKRECC employees will then check to see if there are underground lines in the area, and if so, will mark the route with red flags.

How many feet are safe?

Avoid planting anything under overhead power lines. Before planting, find out how tall a tree will eventually grow. If it will be within 10 feet of a power line when mature, plant it farther from the line. (Many nurseries have planting guides with tree width and height at maturity.)

Don't plant anything that can reach within 6 feet of an electric meter.

When using a ladder to climb on the roof or for some other job, or working on tractors and with farm machinery, the 10-foot rule applies again—stay at least 10 feet from power lines. Be particularly cautious when you are using farm equipment that has extensions. Always lower extensions to the lowest setting when

moving loads. It also helps to have a second pair of eyes to watch for possible contact accidents.

Caution flying kites and drones

Use caution with children flying kites. Make sure they are flown in open areas away from power lines and with adult supervision.

Check local laws before flying a drone near power lines, power plants, substations and other electrical equipment. Flying a drone near electric infrastructure may violate a local ordinance, and a drone crash can cause a power outage.

South Kentucky RECC power lines are necessary to distribute electricity to homes and businesses. Always respect potential hazards when working near our power lines.

The safety of our members and our employees is our highest priority. **DSK**

South Kentucky Annual Meeting 2020

Members will also have the option of using the Quick Pass method on Thursday at the Somerset office. South Kentucky RECC has successfully done this the past several years allowing members to drive through, register and get their bucket and lightbulbs without ever leaving their vehicle.

Important: This type of registration will **NOT** qualify members for the truck giveaway.

Members will be registered electronically at each of the various meetings, making it impossible to register twice. If you go to the meeting at your local office to get your bucket and lightbulbs, then decide to attend the regular meeting in Somerset, you will still need to stop by registration where you will be entered for the vehicle giveaway;



however, you will not receive another bucket and lightbulbs.

“South Kentucky RECC was formed 80 years ago by our members—a group of 10 farmers in Wayne County,” says South Kentucky RECC CEO Ken Simmons. “It’s only fitting that we use our annual meeting each year to recognize and show appreciation to our member-owners, and it’s important that we make it more convenient for them to attend.”

Capital credits for estates

Anyone receiving electricity from South Kentucky RECC is our member-owner. So when revenues are greater than expenses for a particular year at South Kentucky RECC, the difference is called the margin and is divided in the form of capital credits among the co-op's members who received service in that year.

Capital credit refunds were mailed to members in January.

But what happens to those capital credits if a member passes away?

If a member of South Kentucky RECC dies, the co-op will give the deceased member's capital credits to their estate. South Kentucky RECC understands the difficulties families encounter when trying to settle a loved one's estate, so to assist, the co-op continuously takes applications for capital credits of these estates to settle the estate with a final, lump sum payment. In turn, the member can transfer the account out of the deceased member's name and into the executor or new resident's name.

If you are the spouse, administrator, legal heir or agent of a legal heir(s) of an estate of a deceased

South Kentucky RECC member, and have interest in collecting a lump sum payout of the estate of your loved one, you need to do the following:

- 1) Apply in person at the South Kentucky RECC office nearest you. You will be asked to complete the capital credit application form that will be provided.
 - 2) Bring with you to the SKRECC office:
 - a. A copy of the death certificate of the deceased, and
 - b. A copy of the court order appointing you as administrator of the estate of the deceased, or
 - c. A statement from the funeral director that handled the burial arrangements for the deceased.
- For more information, call (800) 264-5112 and ask for the capital credits department.
